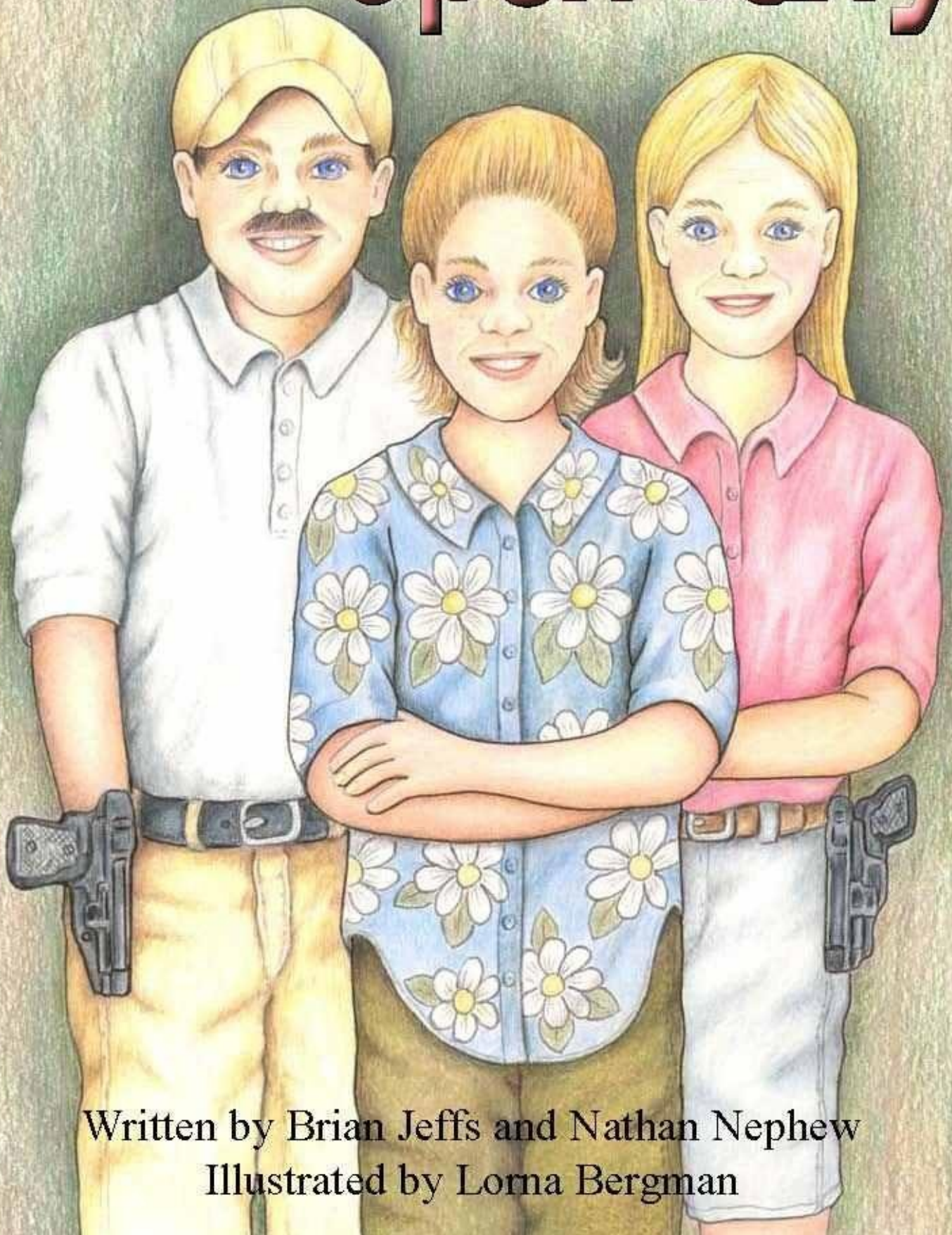

After Mr. Strong and Mr. Wright talked a bit, Mr. Wright said have a nice day and waved once again to the family as they buckled-up and drove away.

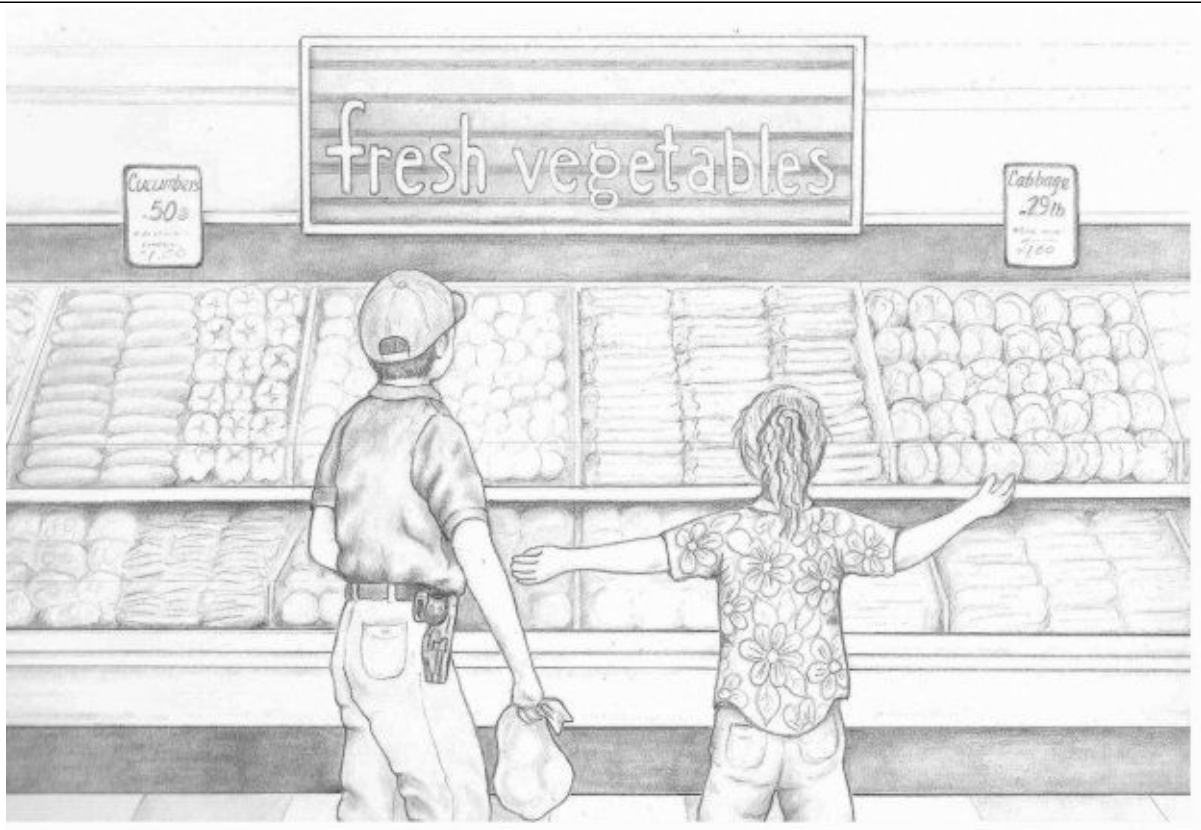

As the family was strolling down the fresh produce aisle, and Brenna's mom was explaining the health benefits of fresh spinach (as Brenna made yucky faces), an elderly man wearing an army veteran baseball cap approached them and thanked them for exercising their 2nd Amendment right.

The old man explained that he had fought in WWII to protect all of our rights, and he wished more people understood what freedom was. He looked at Brenna and went on to say that the 2nd Amendment, the one that states "A well regulated Militia being necessary for a free state, the right of the people to keep and bear arms shall not be infringed," wasn't about hunting or target shooting or even self defense.

Brenna thought about this for a moment, and then it clicked! In fact, it made perfect sense: the “militia” and the “people” are the same thing. The 2<sup>nd</sup> Amendment was about the right of the “people” to keep and bear arms. Brenna’s dad added that for many years some Americans couldn’t exercise their 2<sup>nd</sup> Amendment rights. It was only in 2009 that the US Supreme Court ruled that the right to keep and bear arms was an individual right, and in 2010 the High Court ruled that the 2<sup>nd</sup> Amendment was incorporated to the states. That means that the states have to abide by the Second Amendment just like many other rights.

The Strong family went across the square to the *Sheridan Bookstore* . This was Brenna’s favorite store in town. Brenna made a beeline right to the music section. Brenna’s parents went in different directions; both of them loved to read, and so they looked for a book to buy.

After they browsed the shelves, Brenna's parents sat down in the bookstore's café and talked. Several shoppers wandered the aisles, looking at the wide selection of books and CDs. After a few minutes, a man approached Brenna's parents and asked if he could talk to them about their handguns. Brenna's dad said, "Sure. What would you like to know?" "Well," the man said, "I have a concealed pistol permit, and I always carry my handgun concealed and out of sight. I keep a shirt or jacket over my handgun at all times." "That's good," said Brenna's dad. Brenna's parents didn't care if people chose to open carry or conceal carry as long as they carried and were responsible. Her parents would sometimes conceal carry as well. It's nice to have the option to do either.



The man stated that he didn't open carry because he felt he would be the first person shot if something bad like a bank robbery went down. Brenna's dad grinned a bit; he had heard this myth several times when it came to open carry versus concealed carry.

Brenna's dad told the man that he had never heard of a person openly carrying a handgun being a target or shot during a robbery. This was an image portrayed in TV and movies. In fact, there is more evidence to suggest that people who open carry a handgun deter crimes from happening in the first place. There are several cases of robbers who staked out a store to rob only to go somewhere else because they saw someone with a gun in the store.

“In fact, I had this exact thing happen to me. One morning last summer, my friend and I were sitting in *Woodruff’s Waffle World* on Main St. eating breakfast. As usual, I was open carrying my handgun. Being aware of my surroundings, I noticed a man come into the restaurant and look all around like he was looking for somebody. This seemed a bit suspicious to me so I kept my eye on him and what was going on around us. The man looked at me, glanced down and quickly went back outside. We left *Waffle World*, almost forgetting about the suspicious man. Later that night on the news I heard that the local police had stopped two men in a suspicious vehicle behind that restaurant and the men admitted to planning a robbery that very morning. The men commented that they decided not to rob *Woodruff’s* because they saw a customer armed with a gun on his hip. I believe the customer they saw was me.

Brenna's dad continued, "Criminals like a "soft target" - a target that won't put up a fight. Criminals don't want to face a person who is armed or might be armed. The US Department of Justice interviewed convicted robbers on this subject, and the majority agreed. They want easy targets for crime. So, it may be to your advantage to open carry. It's like a "beware of dog" sign. It says don't mess with me, I'll fight back."

"Well," the man said, "maybe you're right about that, but if you open carry a handgun someone could come up behind you and steal it away from you." "Yes, I suppose that could happen," said Brenna's mom, "But we have never heard of this happening to a citizen. It has happened to police officers because they have to sometimes fight and struggle with criminals that are desperate to get away. And it could happen to a citizen as well, that's why we have good retention holsters."

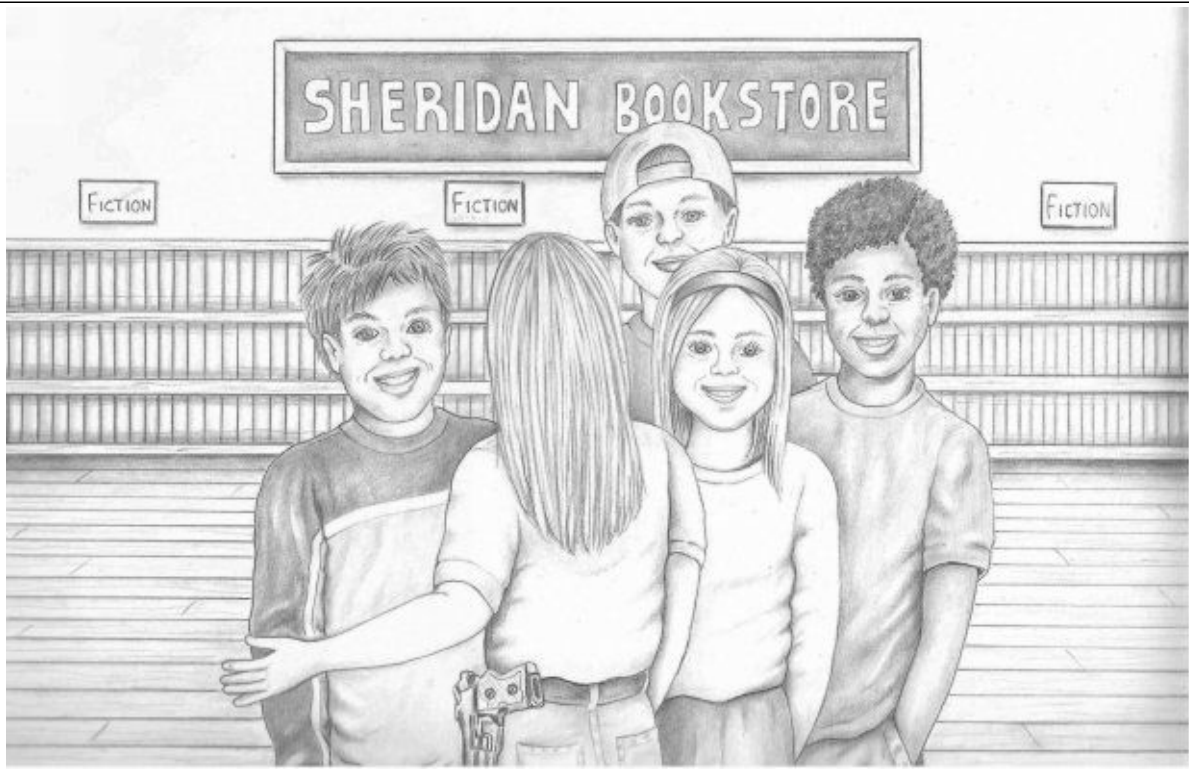
Brenna's mom continued, "Our holsters are designed to only allow the person that is carrying the handgun to draw it. This allows you time to react to an attempted gun snatch. We also stay aware of our surroundings." Brenna's dad added, "Everyone should be aware of their surroundings and other people around them. Crime and evil can happen anywhere at anytime, history shows that."

To increase Brenna's awareness, her dad often tries to sneak up on her to catch her off guard; it's a game they play. If she catches him he has to do the dishes that night. If she doesn't, then she has to do the dishes.

"What about brandishing?" The man asked. He continued and said "I have heard that having a gun in a holster is brandishing." Brenna's dad said "We hear that a lot, but it's not true. Brandishing is waving or pointing your gun in a threatening manner, or emphasizing you're armed in an attempt to intimidate someone. Just wearing a gun in a holster is not brandishing."

The man said he had a lot to think about and would give open carry more thought. Brenna's mom said that many people start out thinking open carry is not for them and that's okay, but many decide to give it a try after they research it and think about it more. The man thanked them for the information and said he would definitely do both. The man and Brenna's parents shook hands, and the man walked back to his family.



As Brenna continued to shop, some teenagers who were curious about her parents' handguns approached them and asked if the guns were real. "Yes," said Brenna's mom, "they're real." "Cool!" said the boy. "Yeah pretty cool," said the girl. "My dad has hunting rifles," said the young girl "He hunts deer." Brenna's parents both nodded and said they too, hunt deer up north.

The boy asked them why they carry their handguns out in the open. "That's a good question," said M Strong. "There are many reasons. Open carry can deter a crime, it's a faster draw, and it's more comfortable in the summer when we wear light clothing. It also brings gun ownership out of the closet and into the mainstream and shows the public that good people keep and bear arms. It lets people know that their neighbors, pastors, doctors, lawyers, and friends bear arms. It lets people realize that guns don't have to always be related to crime. It shows that guns are not evil. Some people do evil things – that's the problem."
